

First and foremost, the COVID-19 emergency orders and declarations by governments around the world have never been accompanied with sworn or verifiable proof to the public. Nothing was ever DEMONSTRABLY JUSTIFIED to the public at the time of the emergency orders - or at any time after. This makes all emergency orders and declarations/proclamations to have no force or effect in law. Government officials who signed emergency orders without the order being DEMONSTRABLY JUSTIFIED at the time of the signing of the emergency order acted outside of statutory authority, and are PRIVATELY LIABLE. The destruction of so many fundamental rights is an act outside of statutory authority, leaving them PRIVATELY LIABLE. A 1959 Canadian Supreme Court decision of Roncarelli versus Duplessis, held an acting Government official - the Premier of Quebec while in office - PRIVATELY LIABLE for damages for acting outside statutory authority. EVERYONE has the right to pursue the gaining of a livelihood. This was not protected by the Police as per section 1.2 of the Police Services Act in Ontario. Similarly where you live if you live outside Ontario Canada. In Canada, the QUEEN allowed this to happen and must be immediately questioned. The QUEEN signed the Canadian Charter of Rights and Freedoms in 1982 and is fine with such criminal breaches.

Wearing a face mask is not safe, and forcing or intimidating someone to wear a mask is a criminal code offense. In Canada, it is 14 years in jail, as per section 245 (1) of the Canadian Criminal Code. As well, section 1.2 of the Police Services Act of Ontario mandates POLICE to safeguard our fundamental rights and freedoms and human rights.

Wearing a face mask drives the person into a hypoxic state, which suppresses the immune system. The face-mask affects oxygenation problems because we are breathing in our own exhaust. We breathe out carbon dioxide, and you are now breathing in more and more carbon dioxide because of the face-mask.

The face mask also creates other types of issues because of facial irritations, etc, due to the touching your face more often. Depending on the type of mask one wears, the exhaust from your lungs, carbon dioxide could travel up to your eyes. As well, the box labels of the masks state that there is no protection from COVID-19.

The most idiotic part of wearing a face mask is that it is like using a chain-link fence to prevent a fly from coming into your house, or a split rail fence to keep mice out.

Viral particles are so much smaller than the smallest pores of masks worn by the average person.

The real pathology that people are experiencing is a pathology that is actually from a secondary to a histotoxic hypoxic injury which has nothing to do with a virus. It has to do with contamination from combustion of fossil fuels, from incinerator burn off's, from the chemtrails, from EMF, from all the different components in the quality of the air. This was present in Wuhan. 5G frequencies at 60 Gigahertz affect oxygen bonding.

On top of that, Iran, Italy, and New York have all the same issues, so if this is a histotoxic hypoxic injury, then, when you are wearing a face-mask, you then compound the problem by allowing your cells to have less oxygen.

The reasons stated for a lock-down does not match to that of a viral injury, rather it is more like an altitude sickness, like a hypoxic injury. This is exactly like a histotoxic hypoxic injury, for which if you are wearing a face-mask, there are various plastics in there, and as one continues to breathe back and forth, the humidity starts to cause that propylene, or whatever the material is in the face-mask, to start to break down and now you are ingesting or inhaling many of these chemicals that are

organophosphates or other plastic components that are in there. Mask wearers inhale all of that, which further exacerbates the histotoxic hypoxic injury.

So the masks don't work at all. It's like building a fence with mosquitoes coming in, and what is far worse, is that you are creating an even worse environment by suppressing your immune system by reducing oxygen intake.

If our goal is to be healthy, the first thing to do is to tell people that they should not wear masks and that they should eat only healthy foods and have a healthy lifestyle. Healthy eating and healthy lifestyles should be mandated, not masks.

Wearing a mask is unnecessary. Wearing a mask contributes to the suppression of the immune system and that people will become sicker. The mask makes things worse.

It is actually more harmful for you to wear a mask. This is opposite to what we are being told. This goes against WHO mandate and yet the majority of doctors will confirm that wearing a mask can only make things worse. The WHO is not a government organization and has ties to the vaccine industry.

Wearing a mask is also an inhumane act on a civilian population. An inhumane act on a civilian population is a CRIME AGAINST HUMANITY under the CRIMES AGAINST HUMANITY AND WAR CRIMES ACT. In this Act, it states "crime against humanity" means "any other inhumane act or omission that is committed against any civilian population". Forcing, encouraging, or intimidating a civilian population to breath in carbon dioxide, or destructive or noxious things by wearing a face-mask is an inhumane act on a population. Omitting to stop governments or other people from wearing a mask is also a crime against humanity. Forcing people to not work is an inhumane act and a crime against humanity - punishable by life in prison.

For Police to not protect rights is also MISCONDUCT. Read sections 80 and 81 of the Police Services Act of Ontario. Similarly where you live if you live outside Ontario Canada.

CRIMINAL CODE OF CANADA:
Administering noxious thing

- **245** (1) Every person who administers or causes to be administered to any other person or causes any other person to take poison or any other destructive or noxious thing is guilty....

To the person making you wear a mask, say this:

"You are forcing me to wear a mask when to do so will cause me bodily harm. This is the equivalent to an assault. Wearing a mask will cause me to have Carbon Dioxide or other destructive or noxious things to be administered to myself. You are violating section 245, subsection 1, of the Canadian Criminal code. I place you under citizen's arrest. Please stay here until a Police Officer attends."

Then call the Police.
