

Would a sane person mix a patient sample (that contains various sources of genetic material and was never proven to contain any “SARS-COV-2 virus”) with transfected monkey kidney cells, fetal bovine serum and toxic drugs, then blame “the virus” (that they never looked for or found in the patient sample) for harm to the monkey cells, and then claim that the resulting man-made concoction is “SARS-COV-2 isolate” and ship it off internationally for use in vaccine and test development?

Because that's the sort of fraudulent monkey business that's being passed off as “virus isolation” by research teams around the world, including right here in Ontario.

It doesn't take a rocket scientist to realize that investigation is needed to determine whether a new virus is causing disease. Public health figures don't simply “know” these things. There are well - established, logic-based steps (known as Koch's Postulates) that have been taught in universities for decades as the accepted means of determining whether a microbe is the cause of a disease.

A modified version of Koch's Postulates can be used to work with a suspected virus.

A primary, essential step in Koch's Postulates is isolation, also known as purification – separate the thing of interest from the diseased host and everything else; then one can do experiments with that purified, uncontaminated thing to see if it:

- can replicate in host cells,
- causes the same disease when introduced into another host
- etc

But without the isolation step, one hasn't really even begun to investigate whether a new virus is causing disease.

Nevertheless, if you read the Methods sections of the published papers claiming to have isolated “SARS-COV-2” (“SARS-COV-2” being the name of the so-called “COVID-19 virus”), you find that in practice virologists have actually been doing the exact opposite of isolating anything.

Instead virologists adulterate a patient sample with sources of genetic contamination - usually monkey kidney cells and fetal bovine serum, as well as toxic drugs.

They then irrationally blame any harm that occurs to the monkey cells on “the virus” that they never even tried to find in the patient sample.

They also perform completely meaningless PCR tests that are utterly incapable of determining the presence of an intact virus, they make meaningless comparisons of fabricated, yes fabricated genomes... and they fraudulently refer to these exercises in illogic as “isolation”.

By publicly claiming they have “isolated the virus” virologist create the false impression that they have been conducting legitimate science and investigating whether Koch's Postulates are satisfied, when in fact they have done nothing of the sort.

By doing this, virologists create a demand for their so-called “virus isolate”, to be used by other researchers for developing “COVID-19” tests, therapeutics and vaccines... all for a never-proven-to-exist, purely theoretical virus.

That is not application of the scientific method, it has nothing to do with public health, it's wild, irrational speculation, and it's blatantly fraudulent.

And so, after hearing from brilliant doctors, scientists and investigative journalists about Koch's Postulates (modified for a virus) and the fact that the isolation step had never been done for the alleged "SARS-COV-2", and starting to verify this for myself by examining the Methods sections of published "isolation" papers, I started submitting Freedom of Information requests to Health Canada and other Canadian institutions to see if they had any record of real "SARS-COV-2" isolation.

My requests were specifically worded to weed out the papers that claimed to have isolated but in fact performed what I call "fraudulent monkey business".

So far the following Canadian institutions have responded: Health Canada

- National Research Council of Canada
- Vaccine and Infectious Disease Organization-International Vaccine Centre
- (VIDO-InterVac) – which claimed to have isolated
- McGill University
- Region of Peel
- City of Toronto
- University of Toronto
- Sunnybrook Health Sciences Centre,
- McMaster University and
- Mount Sinai Hospital (Toronto)

Note that researchers from those last 4 institutions had already publicly claimed to have jointly "isolated the virus", and at least 2 of them are involved in "COVID-19" vaccine development.

Yet all of the listed institutions indicated the same: that they searched their records and located none describing legitimate isolation of any "SARS-COV-2" from a patient sample, performed by anyone, anywhere on the planet, ever.

Interestingly, the City of Toronto repeatedly attempted to "blow off" my request just this past week, "strongly recommending" that I withdraw it; however I refused to.

The assistant registrar for the City then response and stated, *"Staff from Toronto Public Health have advised that they do not have any records related to your scope."*

In other words Dr. Eileen de Villa cannot prove the existence of her alleged virus, is participating in public health fraud and in my personal opinion belongs in jail. For a very long time. It's also interesting to note that FOI responses from several other Canadian institutions to the same request are long overdue:

- Ontario Ministry of Health (submitted May 14, 2020; after some initial emails with the FOI coordinator John Babos, I have heard nothing since June 2, 2020)
- Public Health Agency of Canada (submitted June 13, 2020)
- Public Health Ontario (submitted July 16, 2020)

What are public health officials afraid of? If they were competent and telling us the truth about "COVID-19", rather than obscenely overpaid public health puppets, and if "the virus" actually existed, should this information not be at their fingertips?

When I shared these FOI responses on social media, people from various countries then submitted the same request to institutions around the world. Michael S. in New Zealand has been especially active.

People also started alerting me to other FOI responses posted online. It became a crowd-sourced project, people who had never laid eyes on each other pitching in to jointly collect and share this evidence of global fraud.

As a result of everyone's efforts we now have "no records" responses from well over >30 institutions around the world, some of them are:

- U.S. Centers for Disease Control and Prevention
- U.S. Agency for Toxic Substances and Disease Registry
- New Zealand
- Ministry of Health
- University of Otago – claimed to have isolated
- Australia's Department of Health
- Commonwealth Scientific and Industrial Research Organisation – - involved in "COVID-19" vaccine trials using the so-called "SARS-COV-2 isolate" from the Peter Doherty Institute for Infection and Immunity
- Peter Doherty Institute for Infection and Immunity (which had publicly claimed to have "isolated the virus") Do you see any problem there?
- UK's Government Office for Science
- U.K. Medicines & Healthcare products Regulatory Agency
- Public Health Scotland
- Public Health Wales
- Public Health England
- European Centre for Disease Prevention and Control has admitted to having no documentation, even for their own methodology to prove that a virus exists, let alone proof of SARS-COV-2

To date, no institution has been able to provide or cite even 1 paper showing that "SARS-COV-2" has actually been isolated from even 1 patient anywhere on the planet.

We also have a communication from the U.S. National Institute of Allergy and Infectious Diseases (NIAID) indicating that the EM images they've published did not involve isolation of a virus.

In other words, public health officials have zero evidence to support their story of a "COVID-19 virus" let alone a "COVID-19" pandemic.

What we have here is evidence of global fraud: fraudulent science, a purely theoretical, imaginary virus, meaningless tests, and fraudulent diagnoses.
